# Ohio Legislation that Could Change the Profession...

Two pieces of legislation are being considered by Ohio Legislature. Please read on to learn more. According to Dean Debra Parker, "It is important for our voices to be heard. Anyone who lives in the state of Ohio will be impacted by the outcomes of these bills. I urge Ohio voters to contact their Senators as soon as possible to voice their opinions." Here are summaries you may find useful:

### HB-73: Opposition to the Enact Dave and Angie Patient and Health Provider Protection Act (HB 73)

This bill requires pharmacists to dispense medication for all purposes including off label prescribing without the discretion of the pharmacist and creates a potential drug shortage supply.....

"A pharmacist shall dispense, and a hospital or inpatient facility shall allow the dispensing of an off-label drug to a patient if a prescriber has issued for the patient a prescription for the drug."

This will require a pharmacist to dispense any drug for which there is a prescription, even if it is against their professional judgement. Here is a link to the bill in its entirety. <u>https://search-</u>

# HB 80 : Pharmacist Care, to amend sections 4729.01 and 4729.45 and to enact section 4729.21 of the Revised Code

This bill provides patients more access to basic health care for conditions such as strep throat (test and treat), COVID (test and treat), Influenza (test and treat), and HIV medication administration. This bill would allow pharmacists, in accordance with a statewide written protocol, to conduct screenings, order labs and diagnostic tests, evaluate the results of screenings, and to test and treat the flu, COVID-19, and strep throat. It also authorizes pharmacists, in accordance with a physician approved protocol, to administer by injection (1) HIV treatments drugs in long-acting or extended- release forms and (2) other drugs specified by the Ohio State Board of Pharmacy.

The bill modifies and enhances the services that pharmacists are permitted to provide as part the statutory definition of "practice of pharmacy".

Please ask your House Representatives to <u>support</u> this bill as it is currently in committee.

According to Dr. BasuSarkar, "My motivation is that there was not a single book that was written keeping this core course in mind. The textbooks that are available on the market either do not cover all of the necessary aspects of physical pharmacy in adequate detail, or they dwell on the practice part of pharmaceutics without detailing the physical pharmacy principles that apply. Thus, there was always a lack of a proper textbook for this course which is an essential part of any Pharm. D. program in North America. This book is written to bridge the existing gap in content."

# International Pharmacy Ambassador, Dr. M. Chandra Sekar Recipient of Coveted Fulbright Award

Those who know Dr. Chandra Sekar know he has long advocated for international exchange of ideas and improving healthcare around the globe. His life-long passion has culminated in his receipt of the Fulbright-Nehru award. This award is a highly competitive award that is selected by Fulbright Foundation established by the State Department of US and the Government of India. This award is even more significant because it is the first time the UF College of Pharmacy faculty member has been awarded. This grant will help Dr. Sekar and his team of researchers conduct their proposed project "Improving patient care by empowering community pharmacists in India". This objective will be achieved by carrying out the first randomized control trial of pharmacist management of hypertension, followed by diabetes management in 2024. This grant would not have been possible without active involvement and support of the Co-PI Satheesh S Gottipati, Associate Professor and Dean of Academics from Vignan Pharmacy College, Vadlamudi, Guntur, India.
